

Let Grow Think for Yourself Scholarship Rules

No Purchase Necessary to Apply. A purchase will not (and cannot) increase your chances of winning. SPONSOR: Let Grow Inc ("Sponsor")

- 1. **ELIGIBILITY:** Applicants must be at least sixteen (16) years of age or older at the time of application, be legal residents of the fifty (50) United States, District of Columbia, Puerto Rico, or Guam, and be currently a senior (12th grade) or equivalent in an accredited high school or alternative program such as a micro-school or homeschool, and must enroll no later than the fall of 2027 in a post-secondary institution of higher education (2 or 4 year college or university, trade school, online or vocational school program). Current employees, officers, directors and agents of Sponsor and its related companies and members of their immediate families (defined as spouse, parents, siblings and children) and persons residing at the same address are not eligible to win. Void where prohibited.
- 2. **HOW TO ENTER:** To enter, beginning February 3, 2025, submit a complete scholarship Application online at the Sponsor's Website (https://letgrow.org/program/think-for-yourself-scholarship) between February 3 and April 30, 2025 at 11:59 pm Eastern Time. Only the first 5,000 applications will be accepted, so Let Grow reserves the right to close the contest early if that limit is reached before April 30, 2025. Limit one (1) Application per person. Application must include name and contact information, background details, and a short original, previously unpublished, personally written (No AI generated content) response to one scholarship topic; "Write about a time you unexpectedly had to deal with an adult situation on your own. What independent skills or experiences did you draw from? What did you learn about yourself?" or "What is your favorite memory from real life and favorite one from time online? How would you compare the experiences?" or "Write about a time someone changed your mind about an idea or belief you strongly held. How did this change occur and what did you learn from the process? Is there anything you'll do differently from now on? or "Write about a time you didn't speak up — or almost didn't — for fear your idea might be unpopular. What did you learn from this, and would you do the same thing again?" Your written response must be a personal story or narrative written in English, with correct spelling and grammar, and it must be at least 600 words and no more than 800 words. Any other essay formats (such as Expository) or submission types (such as resumes or bios) will be automatically disqualified and discarded. No substitutions of new drafts or corrected pages will be accepted once you have submitted your original Application. Written responses that are obscene, pornographic, libelous or otherwise objectionable will be disqualified. All applications become the property of the Sponsor and will not be returned. Sponsor assumes no responsibility for lost, late, misdirected, or unintelligible Applications. By submitting an application, you fully and unconditionally accept and agree to these Official Rules and the decisions of the Sponsor, which are final and binding.
- 3. **SELECTION OF POTENTIAL WINNERS:** Sponsor is looking for eligible Applicants who follow directions and submit Applications that are well-written and clearly and creatively address the topic described above. On or about July 15, 2024, a qualified panel of judges will select four (4) potential winners based on the criteria of creativity (25%), originality (50%), and relevance to the prompt (25%). Sponsor will select at least four (4) of the submitted Applications as the potential Prize-Winning Application. In the event of a tie, the potential winner will be the Applicant with the higher score for overall excellence. The potential winner will be notified by e-mail, at which time he/she will be required to sign further documentation as explained below. Sponsor shall have no liability for any potential winner notification that is lost, intercepted or not received by the potential winner for any reason. Sponsor reserves the right to choose no Scholarship Prize Recipient if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Applications. Portions of the Prize-Winning Application may be posted on the Sponsor's Website, or used in other marketing materials, without further compensation or notice to the winner.
- 4. PRIZES: Four (4) winners will receive Scholarship Prizes. One (1) winner will receive eight thousand dollars and zero cents (\$8,000), and three (3) winners will receive a Scholarship Prize in the amount up to two thousand dollars and zero cents (\$2,000). The Scholarship Prize will not exceed the cost of the annual tuition. The Scholarship Prize will be in the form of an ACH payment made payable directly to the accredited post-secondary institution of higher education attended by the Scholarship Prize Recipient (once the Scholarship Prize Recipient has enrolled in an accredited post-secondary institution of higher education and submitted proof of enrollment to Sponsor). Scholarship Prize Recipient must submit proof of enrollment on or before 9/30/2026. Scholarship Prize may not be assigned, transferred, or changed, except at the sole discretion of Sponsor. No cash equivalent prize will be awarded. The awarding of any Scholarship Prize is contingent upon full compliance with these Official Rules and subject to Sponsor's verification of Applicant and Applicant's submission. Applicants agree to be bound by Official Rules and agree that if any Scholarship Prize Recipient fails to provide proof of identity, refuses to provide required affidavit, refuses to complete and provide any requested tax forms (including IRS W-9 form), is found to have violated the Official Rules or otherwise does not meet eligibility criteria. Scholarship Prize will be forfeited and the Applicant who submitted the Application with the next highest score will become an alternate potential Scholarship Prize Recipient. Applicants understand that Sponsor is not liable for injuries, losses or damages of any kind arising from participation in this Scholarship Program and acceptance, possession and use of Scholarship Prize. Sponsor is not responsible for any typographical or other error in the printing of the offer, administration of the Scholarship Program or in the announcement of the Scholarship Prize. - 6. **PUBLICITY:** Except where prohibited, by accepting a Scholarship Prize, the Scholarship Prize Recipients agree that Sponsor may, without any limitation or further compensation or notice, use his or her name, voice and/or likeness in any and all media, worldwide, for the purpose of advertising and promoting the Website, the Sponsor, the Scholarship Program, or any other promotion, contest or sweepstakes sponsored by Let Grow.
- 7. **OWNERSHIP:** By submitting an Application, you acknowledge and agree that: (a) Sponsor will own your Application, including your written response submission, and (b) as between you and Sponsor, Sponsor will own all publishing rights in and to the Application and the written response submission. Each Applicant hereby irrevocably grants, transfers, sells, assigns and conveys to the Sponsor, its successors and assigns, all present and future right, title and interest of every kind and nature whatsoever, including, without limitation, all copyrights, and all rights incidental, subsidiary, ancillary or allied thereto (including, without limitation, all derivative rights) in and to the Application and the written response submission(s) for exploitation throughout the universe, in perpetuity, by means of any and all media and devices whether now known or hereafter devised (the "Rights"). Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter, the Application and written response submission(s) for any purpose which Sponsor deems necessary or desirable, and each Applicant irrevocably waives any and all so-called moral rights they may have in the Application and written response submission(s) submitted by him or her. Each Applicant hereby acknowledges that such Applicant does not reserve any rights in and to the Application and the written response submissions. The ownership of any submission remains the property of the writer, but a completed application constitutes the entrant's permission and consent, without compensation, with or without attribution, for Let Grow to use, reproduce, transmit, post, distribute, adapt, edit, and/or display the submission, should it choose to do so.
- 8. **DISPUTE RESOLUTION:** Except where prohibited, by participating. Applicant agrees that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participants and Sponsor and their agents shall be governed by and construed exclusively in accordance with the laws of the state of New York without giving effect to any principles of conflicts of law of any jurisdiction. Applicant agrees that any action at law or in equity arising out of or relating to this Scholarship Program, or awarding of the prizes, shall be filed only in the state or federal courts located in the state of New York and Applicant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such action. Each Applicant hereby agrees to indemnify and hold the Sponsor harmless from and against any and all third party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of Applicant hereunder.
- 10. **FURTHER DOCUMENTATION:** Except where prohibited, potential Scholarship Prize Recipients (or their parents or legal guardians if they are minors at the time of the application) will be required to complete and return an Affidavit of Eligibility, Publicity/Liability Release, and Copyright Assignment within ten (10) days of notification or the Applicant with the Application with the next highest score will become an alternate potential Scholarship Prize Recipient. If notification to a potential Scholarship Prize Recipient is returned as undeliverable, the Applicant with the Application with the next highest score may become an alternate potential Scholarship Prize Recipient.

- 14. **GENERAL PROVISIONS.** Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the application process or the operation of the Scholarship Program or the Website, to be acting in violation of these Official Rules, to be submitting responses dishonestly or inaccurately, or to be acting in an unsportsmanlike or disruptive manner. In the event of a dispute as to the identity of any entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. If an Application is confirmed by Sponsor to have been erroneously deleted, lost or destroyed, the entrant's sole remedy shall be another Application, if time permits. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that or of any other provision.
